## Chapter 1. Introduction

The National Youth Council of Moldova (NYCM) is a non-political and non-governmental youth organisation that incorporates 46 youth organisations on a local and national level. NYCM is the primary organisation that addresses interests of young people of Moldova and it serves as a unique national platform for influencing cross-sectoral youth policy. NYCM has the mission to promote youth interests in Moldova and to contribute to the advancement of youth structures by developing programs and activities for training, educating, lobbying, and consulting. NYCM is an organization that promotes policies in the youth sector.

The following report was assembled by the National Youth Council as part of the organisation's strategic objectives for the years 2014-2018. During this timeframe, NYCM aims to analyse and evaluate the functionality and effectiveness of youth centres across the Republic of Moldova.

According to the National Strategy for Health Sector Development 2020, young people comprise a quarter of the population of the Republic of Moldova and represent the driving force for development in the country.<sup>1</sup> For this reason, development of the youth sector should be a state priority, and should prompt the adoption and implementation of effective policies for all types of young people. The Ministry of Youth and Sports is a central public institution empowered to and responsible for developing the youth sector. Furthermore, it plays an important role in interagency cooperation with other ministries, public institutions, and civil society in finding solutions to contemporary problems and improving the lives of the young in Moldovan society. The diversification and consolidation of youth services would be most effective in developing the full potential of each young Moldovan.

The first group of youth centers in Moldova, which were initially designed as information centres, and occupied a passive role, have since then evolved and now provide a wide range of services for young people. By 2003, with the support of UNICEF and FISM, the Chisinau National Resource Centre for Youth; the National Centre for Working Youth; the Media Centre; the Video Centre for Youth; and Regional Youth Centres in Soroca, Basarabeasca, Biești, Ungheni, Bălți, Comrat, and Fălești have all been established. Along the way, similar centres, operating as public institutions and public financial authorities, were established in Criuleni, Orhei, Edineț, Leova, Sîngerei, Dubăsari, and Alexăndreni.<sup>2</sup>

Ninety-five percent of youth centres established as public institutions did not have sufficient access to external resources. The majority of youth centres were created by NGOs, and some were later taken under the guardianship of public authorities, which were then made responsible for the centres' financial stability. However, there are also centres created and still operated by NGOs that remain parallel to, but are supported by, public authorities.

Moldovan youth centres have developed a wide range of services that exceed their initial objectives. Services include nonformal education; information services; vocational guidance, training, and professional integration; leisure, sport, and volunteering opportunities; entrepreneurial initiatives; and youth exchange programs.

Coordination and monitoring of youth-friendly health centres is conducted nationally by the Ministry of Health.

The National Network of Youth-Friendly Service Providers is a voluntary union of associations and public institutions that aims to improve the regulatory and legislative framework in the fields of youth and youth services at the local, regional, and national levels in Moldova.<sup>3</sup>

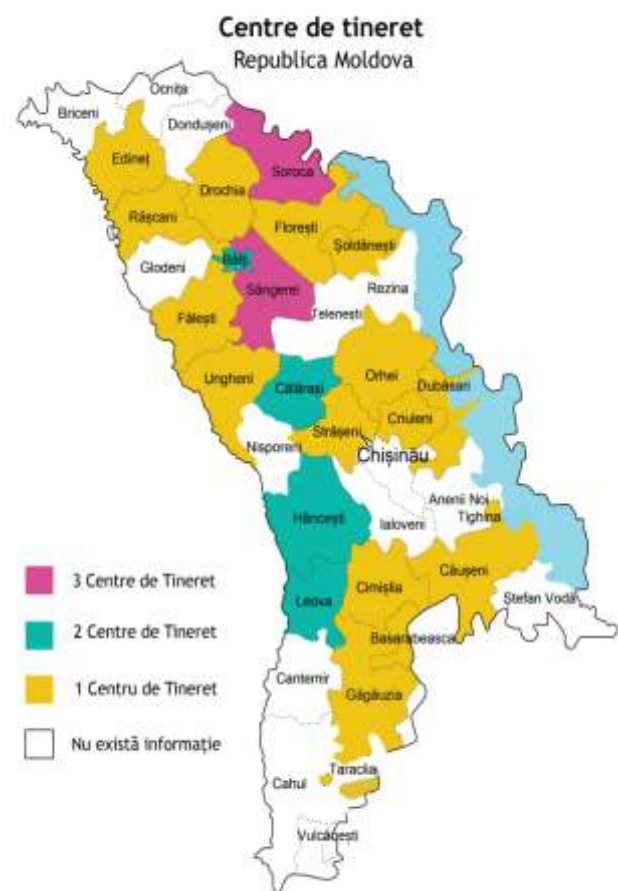
## Chapter 2. Youth Centres in the Republic of Moldova

During transition to democratic governance, the need for youth services has spurred greater action towards establishing and expanding youth centres in Moldova. This new concept was first applied in 2003, when the first pilot youth centres were created. Initially, these centres fell into one of two types: the first type, resource and information centres, aimed to increase youth community opportunities and involvement; and the second, health information centres, aimed to prevent risky behaviors. The evolution of these centres over the last decade has made clear their crucial role in the youth sector and made evident their needs and areas for further maturation.

According to data presented by the Ministry of Finance, the Republic of Moldova has 28 youth centres aimed at diversifying and consolidating services for young people. The highest concentrations of youth centres are found in Soroca and Sîngerei, at three per region.

The regions of Călărași, Hincești, and Leova, as well as the city of Balți, report two youth centres each. Other regions with interest in developing the youth sector, reporting one youth centre each, are Basarabeasca, Căușeni, Cimișlia, Criuleni, Dubăsari, Edineț, Fălești, Florești, Orhei, Râșcani, Șoldănești, Strășeni, Ungheni, and UTA Găgăuzia. There is no existing information on youth centre presence in other regions of Moldova.



The Ministry of Finance annually designates a percentage of the national budget for the coordination of these 28 youth centres. However, according to Ministry of Finance data from 2015, the amount of money actually used by youth centres that year fell short 3,207 million lei of the money initially approved for youth centre use. This discrepancy is due to the Ministry of Finance legally rerouting youth sector funds to areas of higher government priority. The region with the lowest level of government support in 2015 was Floreşti, which received 20 000 lei, and the second lowest, Şoldăneşti. The most government funding went to Criuleni, at 1,039 million lei.

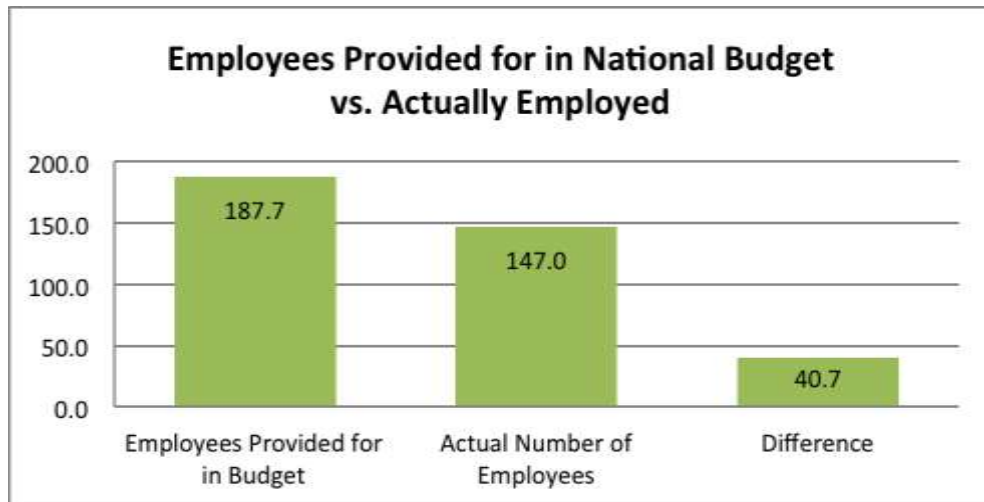

Chart 1, below, shows a shortage of youth centre employees. The Ministry of Finance reported 40 fewer youth centre employees at the end of 2015 than at the beginning of the year.

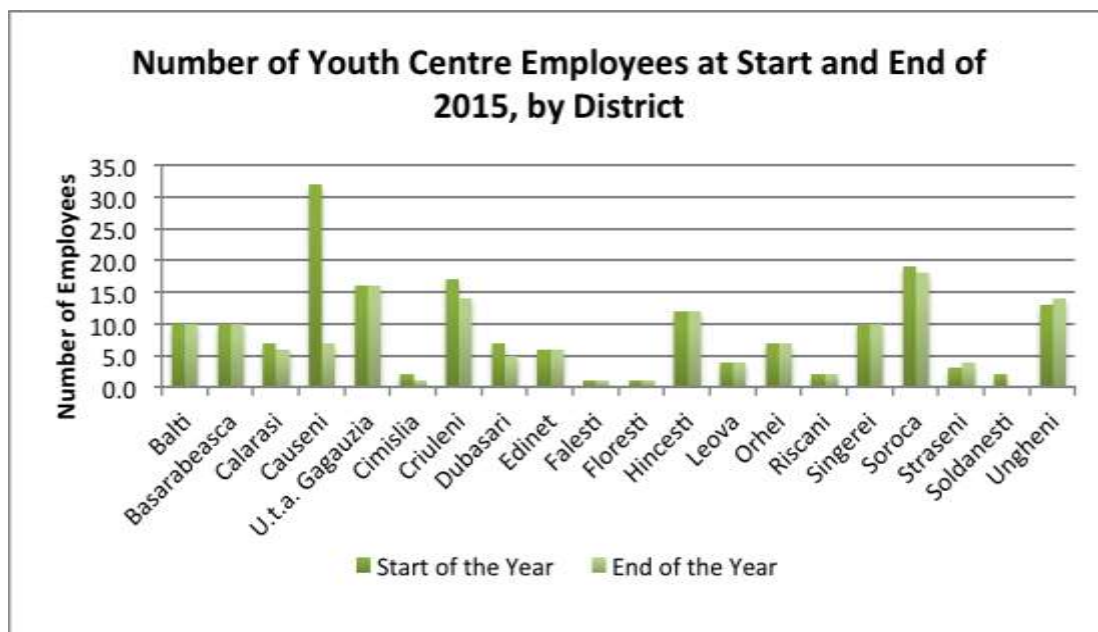

Comparative analysis of employee data from the beginning and from the end of 2015 reveals that although there was a total of 181 youth centre employees across Moldova at the beginning of 2015, this number had decreased to 148 by the end of the year - a national loss of 33 staff members. The greatest loss was in the region of Căușeni, where a staff of 32 began the year at regional health centres and only seven employees finished the year - a loss of 25 employees. The regions of Criuleni and Dubăsari also reported a loss of two to three employees each. However, the number of employees remained unchanged in the regions of Bălți, Basarabeasca, UTA Găgăuzia, Edineț, Hîncești, Leova, Orhei, Rîșcani, and Sîngerei. Reasons for yearly fluctuations in the number of youth centre employees include low salaries, a heavy workload, and lack of cooperation between municipalities and district councils.

If we compare the number of staff positions provided for in youth centre budgets with the number of actual staff members employed at these centres, we note another discrepancy. Based on budget allocation, youth centre support staff should make up 26% of youth centre employees, but in reality they comprise 29% of youth centre staff. Meanwhile, middle management should comprise 62% of youth centre employees, but actually makes up only 59%.

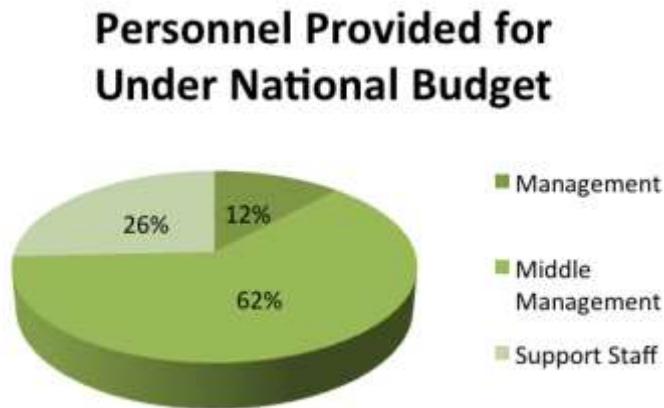
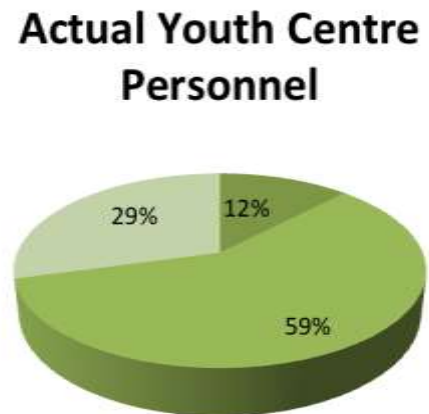


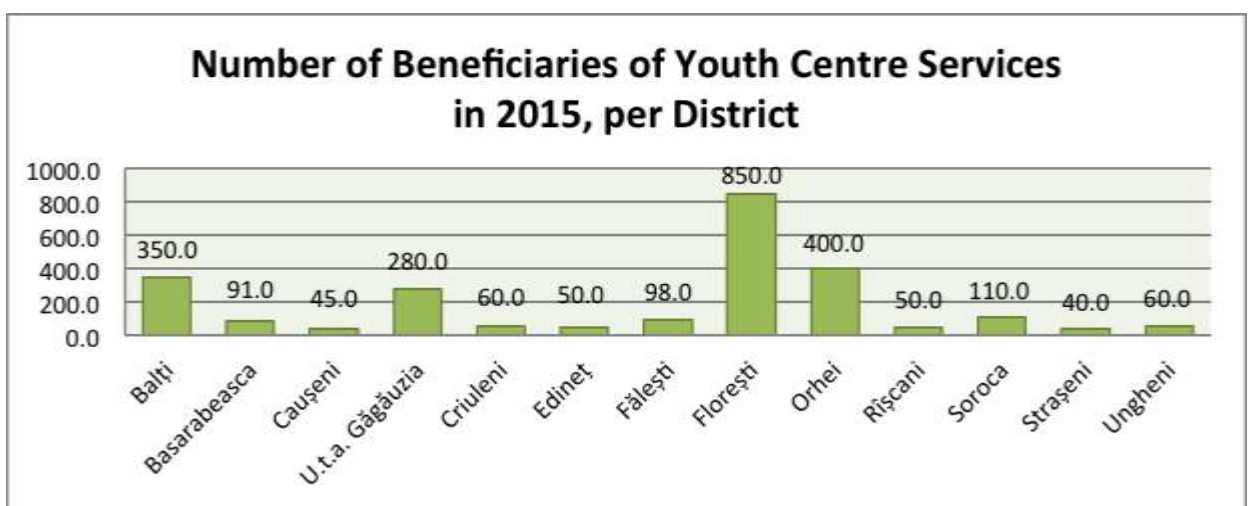

During 2015, Florești reported 850 young people who benefited from the region's youth centres, the highest number in the country. The lowest number of beneficiaries was reported from Strășeni youth centre, at 40.

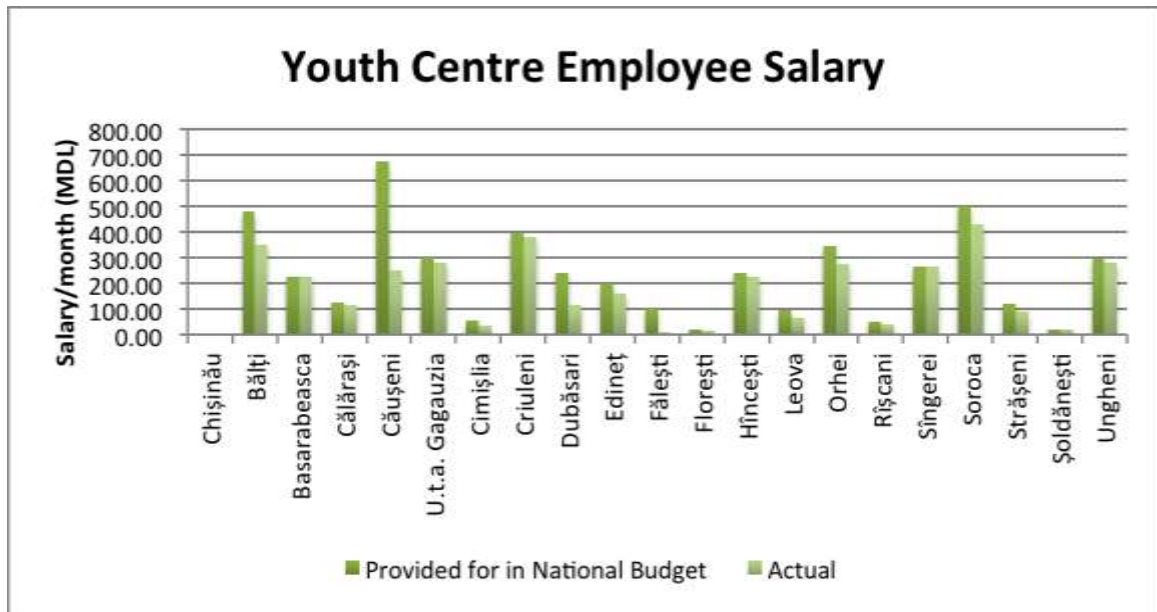

The monthly salary level provided for in the national budget is higher than the actual salary achieved in each district. The largest salary discrepancies in 2015 were in Bălți, Edineț, Fălești, and Orhei.

### Chapter 3. Youth-Friendly Health Centres

A **youth-friendly health centre** is a publicly- or privately-run health institution that works for the public benefit and prioritizes the medical and psychosocial health of adolescents and youth at the community level, simultaneously collaborating with other local institutions and government.

**Coordinating and monitoring activities** at the national level for youth-friendly health centres is conducted by the Ministry of Health via the Neovita Centre for Youth Health, an organization that acts as a resource centre for the network of health specialists and centres providing services to Moldovan youth.

**Coordination and collaboration** of the Centre for Youth Health with other governmental and nongovernmental institutions and partners is achieved through existing legal mechanisms and communication channels.

**Thirty-eight (38) youth-friendly health centres** are active in the Republic of Moldova. Administration of the centres is conducted locally by the director of each centre. Funding is assured through obligatory medical health insurance through the “global budget” system. **Funding for youth-friendly health centres is growing steadily, rising from 7635,0 million lei in 2014, to 10939,4 million in 2015, and finally to 13993,6 million in 2016.**<sup>4</sup>

The **main purpose** of youth-friendly health centres is to improve the health of adolescents and youth and create good conditions for their development and community integration through providing quality health services. In accordance with quality standards and objectives, youth-friendly health centres utilize a mobile service unit with educational, informational, and advisory activities for vulnerable and at-risk youth in isolated areas.

The following diagram presents the main objectives of youth-friendly health centres, in accordance with the Ministry of Health's standards for youth services:<sup>5</sup>

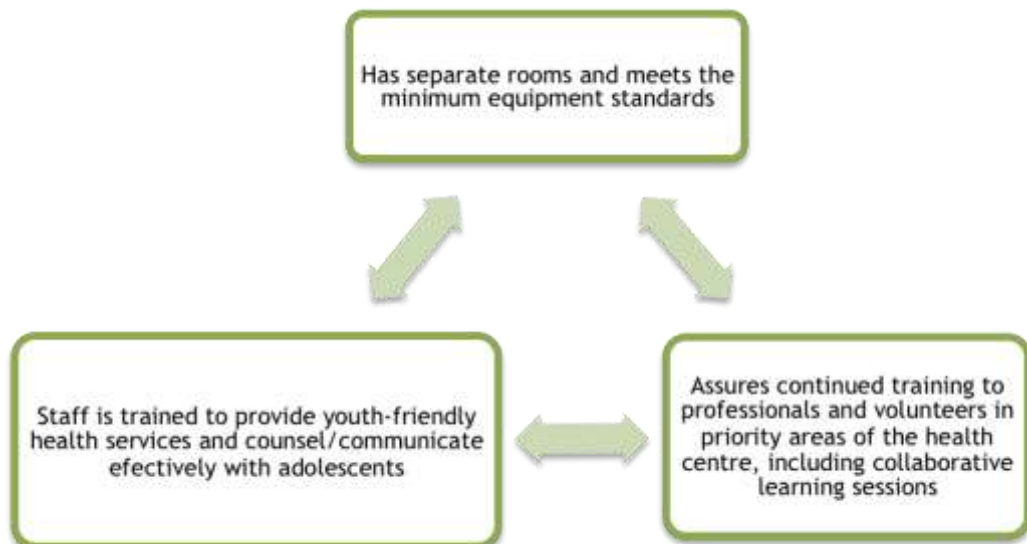

## Chapter 4. National Network of Youth-Friendly Service Providers

The **National Network of Youth-Friendly Service Providers** is a voluntary union of associations and public institutions that aims to improve the regulatory and legislative framework in the fields of youth and youth services at the local, regional, and national levels in Moldova. The Network operates on the principles of voluntary participation and the equality of all its members.

**Network members** operate through the General Assembly, the Network Council, the Working Group, and the Network Secretariat.

**Network activity** is conducted through working groups of organizations and member institutions to pursue the mission and objectives of the Network:

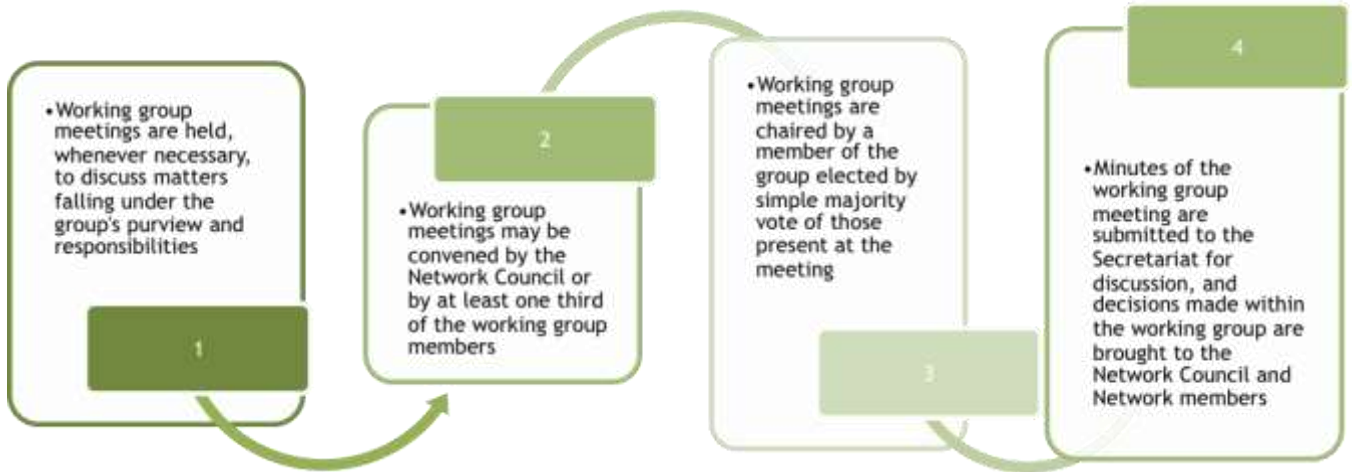

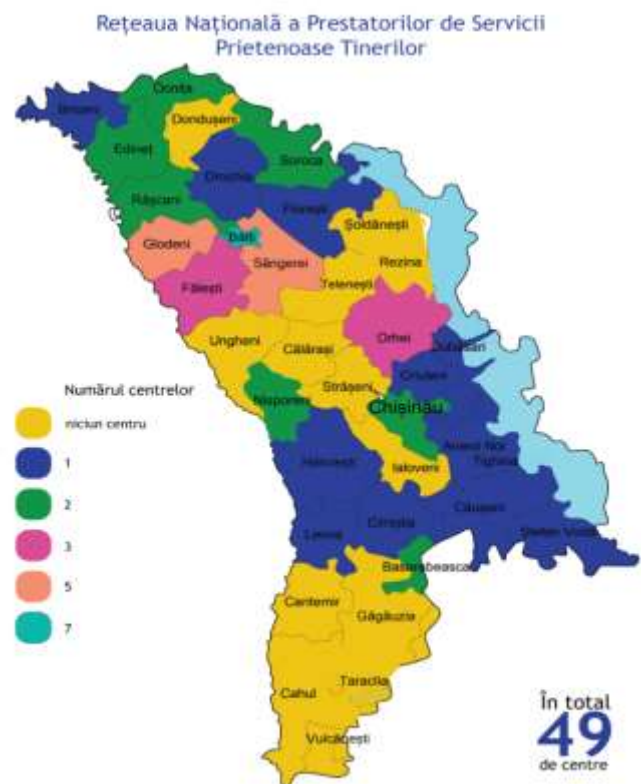

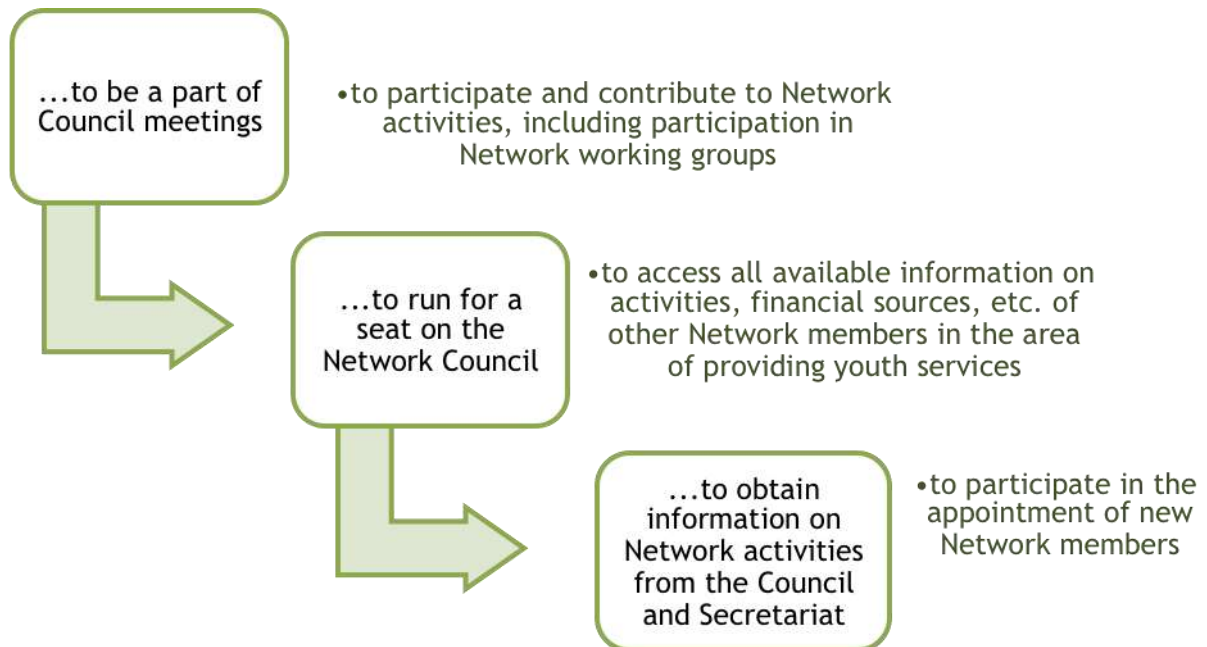
The National Network of Youth-Friendly Service Providers incorporates 49 service providers across Moldova. The greatest concentration of providers is in Bălți, at seven. Fălești and Orhei regions are in second place, with five network members each. Sângerei and Glodeni each have three active providers, while Basarabeasca, Edineț, Nisporeni, Ocnița, Rașcani, Soroca, and Chișinău each have two. The following regions have one youth-friendly service provider each: Bender, Ștefan Vodă, Leova, Hâncești, Florești, Dubăsari, Drochia, Criuleni, Cimișlia, Căușeni, Briceni, and Anenii Noi.



**Network members**, in order to obtain full status as youth-friendly associations or public institutions, are obliged to apply for full membership and to then respect Network regulations.

## Chapter 5. Youth Centres on the Local Level

In order to evaluate the country's youth centres, the National Youth Council of Moldova developed a survey with a range of questions and sent it to 23 youth centres across the country. Eleven youth centres were receptive to NYCM's request for information. Survey questions concerned centres' length of operation, types of activities, number of service beneficiaries, annual budget, etc. Survey responses are presented in graphic form below.

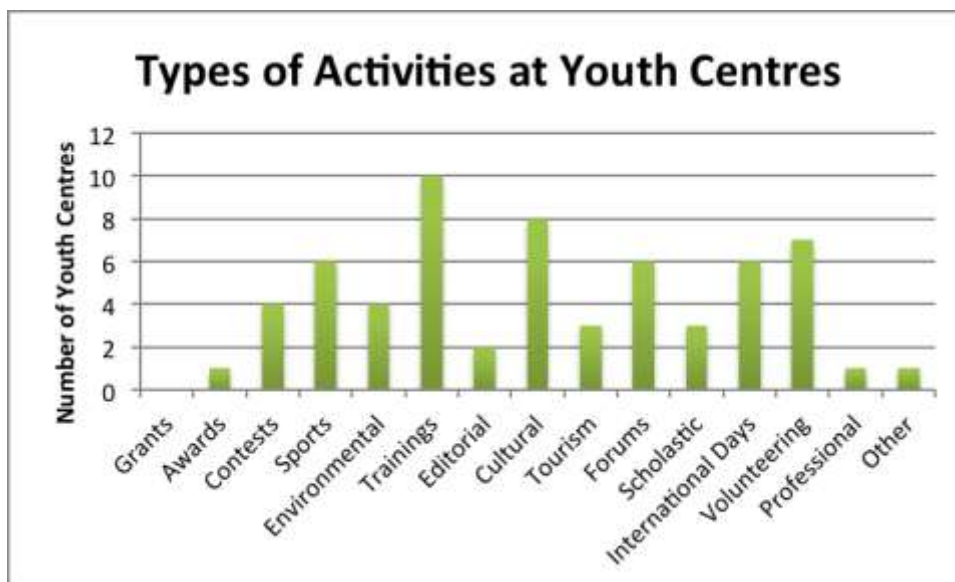
As seen in Chart 7, one youth centre reported an operation period of less than two years, another was established two to five years ago, and the remaining nine youth centres have been operational for over five years.

Activities conducted by youth centres include the following: awards, present at one youth centre, constituting 9,1% of respondents; civic competitions, present at four centres, constituting 36,4% of respondents; sports activities, at six centres, constituting 54,5% of respondents; ecological/environmental activities, at four centres, constituting 36,4% of respondents; trainings, at 10 centres, or 90,9% of respondents;



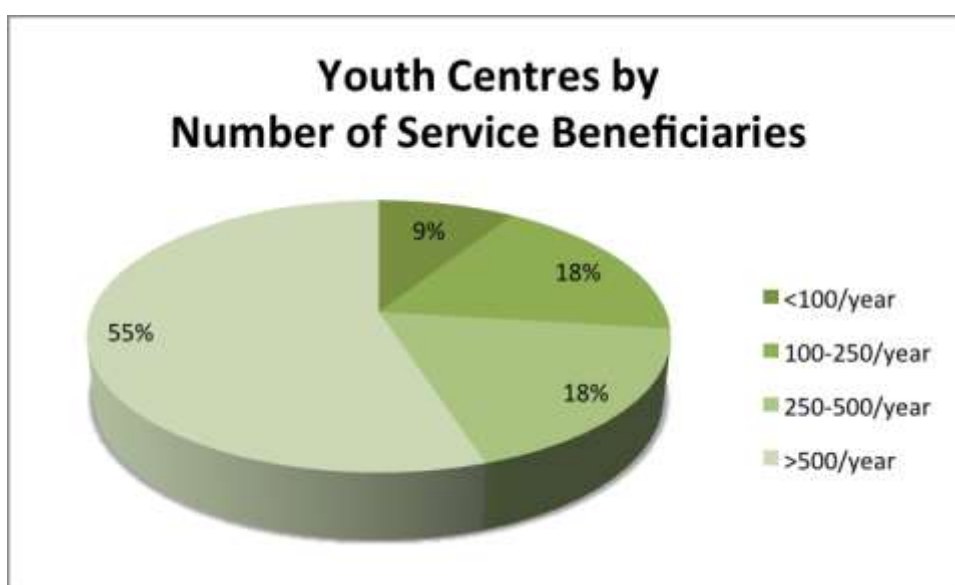
editorial/newspaper activities, at two centres, or 18,2%; cultural activities, at eight centres, 72,7%; youth tourism and excursions, at three centres, 27,3%; youth forums, at six centres, 54,5%; scholastic advancement activities, at three centres, 27,3%; international days, at six centres, 54,5%; volunteer programs, at seven centres, 63,6%; and professional development, at one centre, 9,1%.

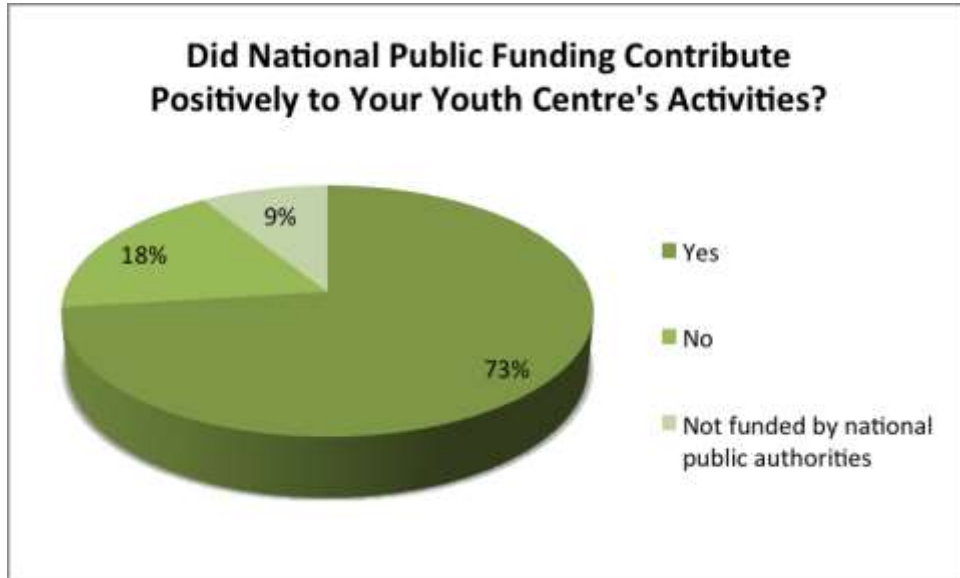
As seen in Chart 9, the majority of youth centres, 55,0%, serve over 500 beneficiaries annually. Eighteen percent (18,0%) of youth centres serve between 100 and 250 young people annually, another 18% between 250 and 500 beneficiaries. Only one center, constituting 9,0% of the sample, serves less than 100 young people per year.

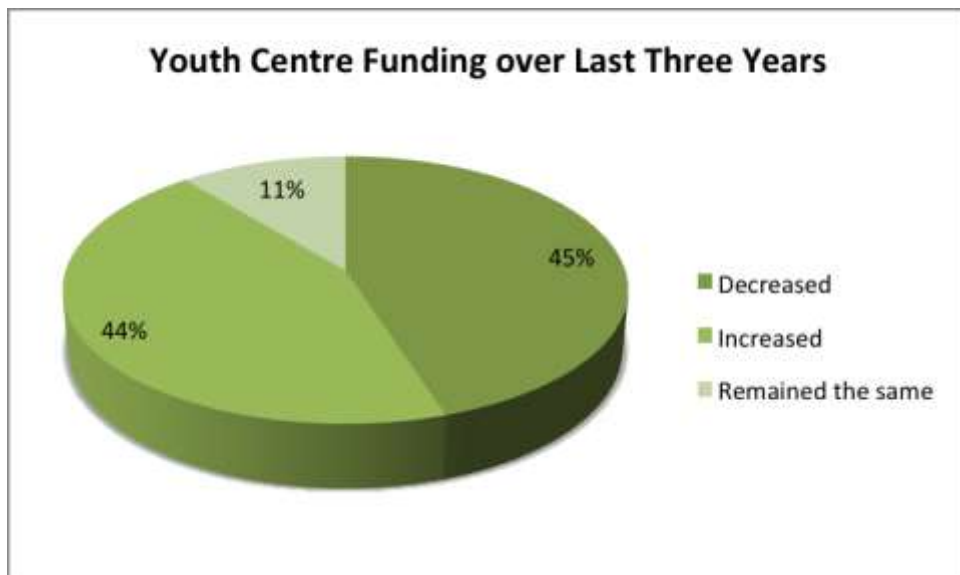
According to Chart 10, which analyzes the effectiveness of funding from national public institutions, 72,7% of respondents experienced a considerable positive impact due to funding from public institutions, while 18,2% did not experience any change in their activities. One youth centre only received funding from local public authorities and, therefore, could not respond knowledgeably.

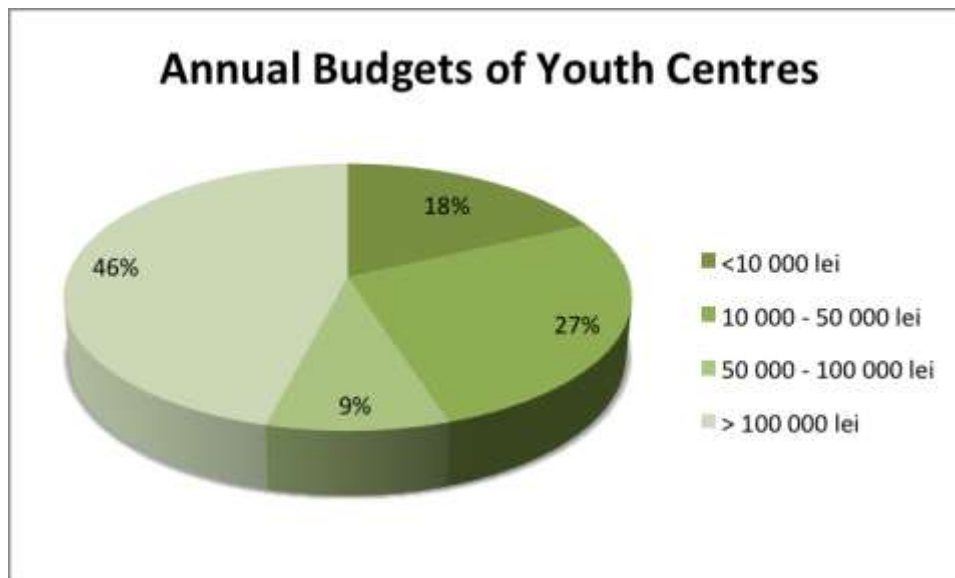
As seen in Chart 11, an equal number of youth centres experienced a growth as experienced a decline in funding over the past three years, and funding for 11% of respondents remained constant over this time period.

According to Chart 12, concerning the annual budget of youth centres, we note that more than 100.000 lei is earmarked for almost half of all centres, at 45,5%, and 9,1% of centres are allocated 50.000 to 100.000 lei. Between 10.000 and 50.000 lei is budgeted for 27,3% of centres, and 18,2% of centres are allocated under 10.000 lei per year.

Presented in the table below are sources of funding for youth centres in 2015. Eight youth centres are completely funded by their district councils and town halls. However, some youth centres diversify their funding through use of private donations, charities, national and international grants, and income-generating/fundraising activities.

The following was discovered with further analysis: five centres in the study (45,5%) collaborate with public institutions at a local and national level through professional dialogue and exchange of experiences on concrete social issues and challenges; nine centres (81,8%)



collaborate directly with their young beneficiaries; two youth centres (18,2%) address and find solutions for individual youth cases; three centres (27,3%) take advice from public authorities on various topics; four centres (36,4%) engage in joint community projects; two youth centres (18,2%) form joint advocacy groups; and three centres (27,3%) hire staff through local public authorities.

## Chapter 6. Conclusions and Recommendations

This evaluation of youth centre activities across Moldova encompasses 28 youth centres, 38 youth-friendly health centres, and the members of the National Network of Youth-Friendly Service Providers. Eleven youth centres were surveyed in order to get a clearer picture of the Moldovan situation. All these sources contributed to the analysis, with the following conclusions:

Within the territory of the Republic of Moldova is a total of 28 youth centres aimed at diversifying and consolidating youth services.

Moldovan youth centres suffer from a lack of employees, with 40 budget-provided positions unfilled across the country. Political instability and low salaries demotivate workers in the youth sector from staying longer than one year, and comparative analysis shows a national loss of 33 employees over a one-year period. In addition, based on budget provisions, youth centre support staff should constitute 3% less of total youth centre employees, and middle management should make up 3% more of total employees.

There is a large gap between the salary level provided for in the national budget and salaries in effect at youth centres. The largest differences in salary levels are found in Bălți, Edinet, Fălești, and Orhei.

Many youth centres at the local level have been active for more than five years. A lack of newly established youth centres shows a non-interest in further development of the youth sector. The most prevalent types of youth centre activities are trainings, followed by cultural and volunteer activities. Most youth centres serve more than 500 people in their region.

Funding for some youth centres is growing, and for others is decreasing. Sources of funding are diverse: national and international charities, private donations, and grants. However, most centres

rely completely on finances from district council and town hall budgets, which demonstrates a lack of sustainable financial diversification.

In the context of the preceding conclusions, we recommend the following:

- Increase the number of youth centre employees to correspond to the number of positions provided for in the national budget;
- Hire more middle management personnel, since current numbers are insufficient;
- Raise salary levels to maintain employee satisfaction and avoid staffing fluctuations;
- Diversify services to reflect the needs and preferences of regional youth;
- Create dialogue with other youth centres to better tackle youth issues and optimize services;
- Collaborate with local public authorities and other nongovernmental organizations;
- Diversify sources of funding;
- Open youth centres in under-served regions: Cahul, Cantemir, Glodeni, Briceni, Ocnîța, Dondușeni, Rezina, etc.
